

Special benefits for Single-parent households

**We will provide benefits to support
single-parent households !**

● People eligible for the benefit

■ Any one from ① to ③

- ① **A person who has received child rearing allowance** for June 2020.
- ② Those who have stopped receiving child support allowances *for June 2020. and is **receiving public pension***1
- ③ **A person** whose home finances has drastically changed because of the coronavirus and **has the same income standard as a person who is receiving child rearing allowance.**
 - ※1 Survivor pension, disability pension, old age pension, work accident pension, survivor compensation, etc.
 - ※2 Those who have approved to receive child allowances are not the only ones eligible. **If you had applied for child rearing allowance, even though payment of the full or partial allowance for the month of June 2020 has been stopped, you are still eligible.**

(1) Basic benefits 50,000 yen per household, 30,000 yen per child from the second child

(2) Additional benefits 50,000 yen per household

If you belong to either ① or ②, for the people whose incomes have decreased due to a drastic change in household finances due to the novel coronavirus disease, you are eligible to receive additional benefits aside from the benefit above.

※ Households receiving welfare are not eligible for additional benefits

Benefit payment procedures

Has received child rearing allowance for June 2020 (People who belong to ①)

- ▶ Basic benefits have been transferred on July 30th to the account the child rearing allowance for June, 2020 had been paid.
Those who have not received child rearing allowance for June because they were still applying, will receive notice one by one after being paid.
- ▶ **Application is required for additional benefits.** Information will be sent to the eligible people around mid-August. (Welfare recipients are not eligible)

Others (People who belong to either ② or ③)

- ▶ **Application is required for basic benefits and additional benefits (person of ②)**
- ▶ For details, please see the Osaka City website (see URL below).

▶ **Those who want to ask questions directly about the application method or want to confirm that the submitted documents are correct** We will have **an intensive consultation** where you can directly ask about the application method, etc.

- ① **August 18 (Tue) to 21 (Fri), 23 (Sun) 10am-4:30pm** ※Japanese only
- ② **August 24 (Mon)-28 (Fri), 31 (Mon) 1:30pm to 7:00pm**
