

# 2023 Livelihood Support Special Benefit for Low-income Households Raising Children (for Non-single Parent Households)

## 1. Eligible Recipients

- Those who meet either of the below conditions ① or ② .
  - ① Those who were eligible for the “2022 Special Benefits for Child-rearing Household Life Support for Low-income Child-rearing Households (for low-income child-rearing households other than single-parent households)”
  - ② Parents of eligible children (under 18 years old as of March 31, 2023 (under 20 years old for children with disabilities), affected by increased prices such as food expenses after January 2023. Also those whose household finances have changed suddenly since then, and whose estimated income is at the same level as that of households exempt from per capita resident tax for 2023 (sudden change in household finances)  
(Note) Newborns born between March 1, 2023 and February 29, 2024 are also eligible.

## 2. Amount of Benefit

50,000 yen uniformly per child **(1 time only)**

### 3. Benefit Payment Procedures

#### ■ Those who received (Corresponding ① on front side 1))

- ▶ For those who received "2022 special support for Child-rearing Households for Low-income Child-rearing Households Benefits (for low-income child-rearing households other than single-parent households)", there is no need of another application and payment was made on Tuesday, May 30, 2023.
- ▶ For those who are exempt from resident tax and have a newborn born between March 1, 2023 and February 29, 2024 (requires application for child allowance, etc.), information will be sent sequentially.

#### ■ Applicants other than the above (Corresponding ② on front side)

- ▶ **An application is required** to receive the Benefit.

##### 1 Application period

##### **By Thursday, February 29th, 2024 (postmark valid)**

- (※) • In case that the application is not completed by the deadline date, or the bank remittance is not made by Friday, March 29<sup>th</sup>, 2024, due to account error or other cause, the Benefit will not be paid.
- Even after the application, payment may not be made if the requirements of payment cannot be confirmed.
