

2023 Livelihood Support Special Benefit for Low-income Households Raising Children (for Single-parent Households)

1. Eligible Recipients

- Those who meet any of the conditions shown in ①~③ below. (Also, those deemed a "Child Caretaker" by the Child Rearing Allowance Law are eligible.)
- 1 Those who received the Child-rearing Allowance for March, 2023.
- ② Those who were unable to receive the Child-rearing Allowance for March, 2023 due to receiving public pensions (such as bereaved family pension, disability pension, old-age pension, workmen's accident pension and compensation for bereaved family, etc.) (However, it is limited to those who have an income less
 - (However, it is limited to those who have an income less than the maximum amount of payment limit for the Childrearing Allowance.)
- ③ Those who did not receive Child Rearing Allowance for March, 2023, but whose finances have been affected by increase of costs for food etc. after January 2023, and who's expected income is the same as those receiving the Child Rearing Allowance.

2. Amount of Benefit

50,000 yen uniformly per child (1 time only)

3. Instructions for How to Receive the Benefit

- Those who received Child-rearing Benefit for March, 2023 (Corresponding to ① on front side 1)
- ▶ For those who received Child-rearing Benefit for March, 2023, there is no need to apply again and the payment was made on Tuesday, May 30, 2023.
- ▶ In the future, if it is approved that in the past requirements to receive the benefit were met and the benefit amount for March 2023 can be disbursed, instructions will be sent accordingly.
- **■** Applicants other than the above

(Corresponding to either of ② or ③ on front side 1)

- ▶ An application is required to receive the benefit.
- 1 Application period

By Thursday, February 29th, 2024 (postmark valid)

- (※) If the application is not completed by the deadline date or the bank remittance can not be made by Friday, March 29th, 2024, due to account error etc., the benefit will not be distributed.
 - Even after the application, payment may not be made if the requirements of benefit cannot be confirmed.
